

**FIRST AMENDMENT TO CONDOMINIUM DECLARATION
FOR
LAS ROSAS, A CONDOMINIUM**

This First Amendment to the Condominium Declaration for Las Rosas, a Condominium (the "First Amendment"), amends that certain Condominium Declaration for Las Rosas, a Condominium, dated December 29, 2004, and recorded as Instrument # 1361436 of the official records of Santa Fe County, New Mexico, on January 4, 2005 (the "Declaration")

Pursuant to the power to amend reserved to the Members of the Las Rosas Condominium Association, Inc. a New Mexico nonprofit corporation (the "Association"), under Article 5 of the Declaration, the Members, as approved by written consent of Owners of Units to which at least seventy five (75%) of the votes in the Association are allocated, or as deemed approved based on the failure of one or more Owners to vote in person or proxy at a meeting properly called for that purpose, do hereby amend the Declaration as follows:

Section 1.2, entitled Defined Terms, setting forth the definition of "Property" is hereby revoked and the following inserted in its place:

Property: All of that certain real property shown on the plat title "First Amended Survey of Las Rosas Condominium" prepared by Dawson Surveys, Inc., dated February 9, 2016 and recorded on April 11, 2016 in the Office of the Santa Fe County Clerk in Book 881, Page 204, as Instrument No. 1790915 (the "Plat and Plans").

Section 2.1, entitled The Buildings, is hereby revoked and the following is inserted in its place:

2.1 The Buildings.

The location, dimensions and area of the buildings on the Property are depicted on the Plat and Plans.

For informational purposes, the foregoing amendment will not have any effect on the one-third ownership interest in the Common Elements or the one-third liability for Common Expenses set forth in Condominium Declaration section 2.2.

IN WITNESS WHEREOF, the Declaration is hereby amended as set forth herein effective the 11th day of April, 2016.

The undersigned President of the Association hereby certifies that this amendment was deemed approved based on the failure of one or more Owners to vote in person or proxy at a meeting properly called on March 10, 2016, for the purpose of considering the foregoing amendment.

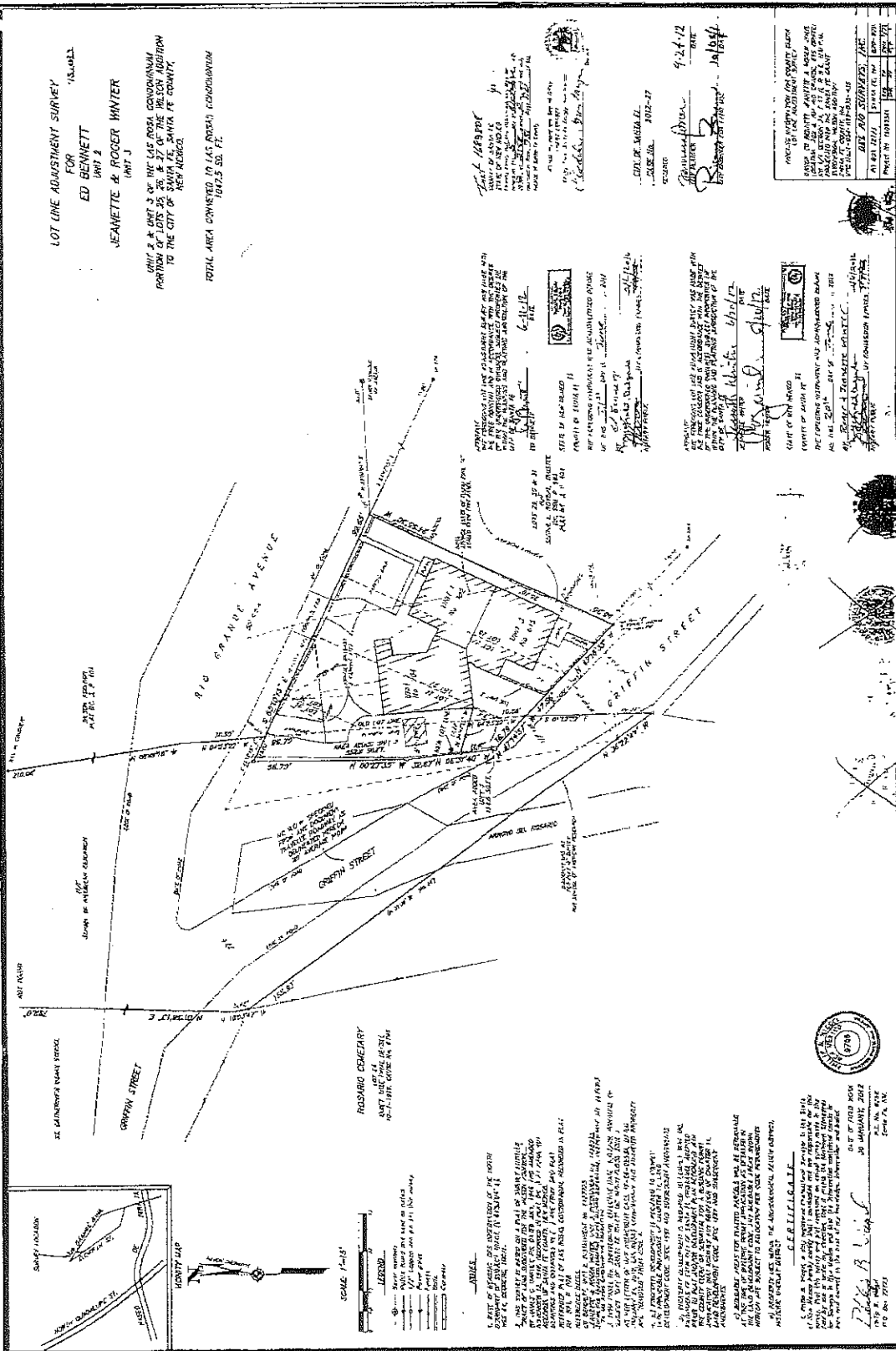
